I would personally like to say thank you to all of our dedicated lifesavers for their efforts in making sure we had no preventable loss of life on our beach again this season. Well done team Cooly.

This season our 12 Patrol groups put in a massive 7648.27 hours on patrol to protect our beach for the 58811 beach visitors. Our members completed 40 rescues, 1235 preventative actions, 82 minor First Aid treatments, 10 major First Aid treatments and warned 1495 people to stay safe and swim between the flags.

Total membership has grown this past season to an impressive 619 members overall, from this we had 242 Active members and 150 Nippers. These increased membership numbers show just how well Coolangatta SLSC is going and that was highlighted by Coolangatta being awarded the Point Danger Branch Club of the Year for the 2022/23 season.

We are now in our 2nd year of partnership with Hillcrest Christian College, this is proving to be a very successful venture for us with many of their students' attending patrols and helping out around the club plus some of their teachers stepping up and doing their Bronze Medallion awards.

2024 was yet another big year for our annual Bronzies Day combined with our Fallen Lifesavers Memorial Day. As usual Danny Hoyland OAM led the way as we welcomed our special guests to the event. These included Gail O'Neill – GCCC Councillor for Div. 14, Karen Andrews MP- Federal Member for McPherson, Gerard O'Brien – SLSQ President, George Hill – South Coast Branch President, Darren Woodward – South Coast Branch Treasurer, Tim Ryan – Sunshine Coast Branch President, Inspector Bruce Kuhn – Coolangatta Police and Sen. Sergeant Andy Goldsworthy – Coolangatta Police. Each of the 25 members who completed their Bronze Medallion this season were presented with patrol caps embroidered with their very own membership number in front of 80 Coolangatta SLSC members and guests.

Following the formal cap presentation, we remembered our own, the Fallen Lifesavers and Family members who had passed away this season. Around 50 Coolangatta Lifesavers fully dressed in their patrol uniform and all invited guests stood in line side by side at the water's edge to watch the placing of the wreaths at sea by our own IRBs. This event was broadcast on all local TV channels giving Coolangatta SLSC a lot of positive publicity.

Coolangatta's Chief Training Officer Kylie Keegan together with her team of trainers have once again achieved fantastic results with 25 new or returning Bronze Medallions, 20 ART, 36 SRC, 45 First Aid, 16 SSV, 13 Tractor, 8 Beach Management, 6 IRB Drivers and 12 IRB Crew awards completed. On top of this Kylie organises all our Skills Maintenance days, together with the great support crew that help with all of the training and assessments.

This year our Annual Dinner/Awards night held on the 1st of June took on a special theme, the Coolies Casino Royale evening. From all reports of those who attended it was praised as one of the best nights that our club has put on for many years. The entire Supporters club was opened up exclusively for our members and guests to enjoy a night of fun, dancing, relaxing and celebration. Big thank you to Naomi, Annette, Kylie, Tracy, Gab and everyone else who made this a night to remember. It is with great pleasure that I present this report showcasing another season of remarkable growth, achievements and progress for Coolangatta SLSC.

The club membership has continued to grow across all categories. Our targeted recruitment campaigns, coupled with positive word of mouth and an exceptional club culture, have been instrumental in the continued growth of our membership. The growth in numbers of both the Nippers and the Cobias has significantly contributed to the club's success. Total membership has continued to increase by 12% (on 75% from last season), active membership has risen by 5% (on 59% from last season), and Nipper membership has surged by 22% (on 112% from last season). Furthermore, our membership retention rate is 73% reflecting our efforts to provide an engaging and rewarding experience for our members.

The board continues to review our strategic plan and achievements monthly, ensuring transparency and accountability in our operations and strategic initiatives. We have continued to supply members with opportunities to provide feedback through member surveys and the suggestion box. The tremendous amount of constructive feedback received from the survey has been analysed and prioritised by the Board, and we are working through the implementation of the excellent suggestions proposed by our members. As a Board, we are committed to providing a positive member experience, and we can only provide that with your support and input through surveys and the suggestion box. Suggestion box submissions are a standing agenda item and where personal details are provided, we will always provide a response to your suggestion following our monthly meeting. We would also encourage members to come and speak to a Board member if you have ideas and suggestions throughout the season.

This season, as a result of the member survey, we hosted a Board information session for any members looking to take on a position or join a committee. We have reviewed our member recognition initiatives and have updated the member of the month form to award of the month and introduced rescue of the month and community achievements so that we can acknowledge and recognise the great things that our members do around the club and in the community.

The executive has continued to review and update the club by-laws over the past twelve months to ensure that they are relevant and align to our constitution and the needs of the club and our members.

Congratulations to Tracy Maidment (Andy Frizzell), Peter Selosse (Assessor), Gary Gee (Masters Athlete), and Nigel Ward (Clive Hammond), for winning their nominated category at the Point Danger Branch awards last season. As a club we also won Patrol Club of the Year, Nipper Program of the Year and Club of the Year, a fantastic recognition for the amazing season we had in 2022/23. We continued to nominate members for service and recognition awards both within Surf Life Saving and the wider community. This season Kylie Keegan (Volunteer of the Year) and Chloe Dunemann (Young Person of the Year) were recognised as winners at the Laura Gerber 2023 Currumbin Champions Awards. Kylie Keegan, Bradley Marsden and Terence Simpson were also recognised at Karen Andrews 2024 McPherson Community Achiever Awards for the contributions to Surf Lifesaving. Jemma Wagner was recognised as the Point Danger Branch Youth Member of Month in April 2024. The Coolies continues to evolve with a change of format this year and a great night had by all who attended. Thanks to the social committee lead by Naomi Currie and our emcee Daniel Hoyland OAM for a great night. These improvements in member recognition have fostered a sense of camaraderie and motivated our members to excel.

Bella has continued to work closely with the Supporters Club to increase our social media presence on the club's public facing digital media platforms. This has enhanced our visibility enabling us to connect with a wider audience and engage our local community. During the winter period Bella will be working with the supporter's club to redevelop a club website.

This season we continued to offer a number of community engagement initiatives to educate the community, by conducting CPR and beach safety sessions. Our community partnership with Hillcrest Christian College has continued to strengthen and grow. This season we had a new group of year 9 students

complete their SRC, some of last year's students have committed to attending regular patrols, we have also seen a great presence from the students and teachers at club fundraising events such as Coolangatta Gold and Cooly Rocks On as part of their community engagement project. The club was also the beneficiary of a fundraising fun run that the students conducted this year.

We welcomed our new Club Chaplain Howard Froese. Howard has made himself available to our club members should they have any wellness concerns or simply need someone to talk to.

We have provided support and opportunities for our members to attend multiple development programs and seize various opportunities. Lachlan Mashall and Alastair McConnell attended the Youth Excellence Program. Jemma Wagner attended the SLSQ Leadership Excellence Program, the SLSQ Lifesaving Development Program, and the SLSQ Advanced Lifesaving Development Program this season. We had a number of youth, and leaders attend the Gold Coast Youth Development Program and the Gold Coast Youth Ball. By nurturing their growth and expanding their skills, we ensure a strong and capable membership base. Congratulations to all members who have taken up this opportunity for personal development. If you want to know more about the opportunities available to you, please come and speak to us.

We continue to collaborate with our Supporters Club Board by holding quarterly joint meetings with. These meetings facilitate open communication, shared insights, and strengthened our partnership to achieve common goals. This season there has been a focused on the building redevelopment proposal, marketing and environmental sustainability plan. As one club we continue to make decisions with our sustainability strategy in mind. I would like to thank Jemma Wagner for taking the lead on a number of projects in this space this season. This season the club joined Take 3 for the Sea' with Jemma being the club's representative and regularly attended their workshops. She planned and conducted sustainability lessons for all our nippers and assisted in coordinating a beach clean-up. As a club we reviewed our sustainability practices including reducing general waste, implementing recycling initiatives such as the 'Upparel' uniform recycling bin.

Treasurer



When reflecting on the past 12 months to prepare this report, I have to sit back and think what an impressive year we've had with a lot to report on, so I'll try to keep it short, sharp and to the point. I've been fortunate to have an incredibly supportive board who are measured and controlled in their spending whist still ensuring that we cater for the needs of members, all operational segments of the club, maintenance requirements, equipment purchasing requirements and our fixed operational costs.

We have achieved good results with a total surplus of \$820,308 an improvement upon last year by \$206,728. This is primarily driven by increased distributions from the Coolangatta Surf Life Saving Supporters Club.

Each year we see more regulation and compliance and whilst this is to ensure that charities and not for profit organisations like ours are doing the right thing and are being open and transparent, we start to become more like a business in our operations. This year we've seen a number of achievements and improvements in what we do from a systems and compliance perspective, ranging from where we have implemented governance controls in accordance with ACNC guidelines around conflict of interest, related party transactions and self-assessment reviews, to the implementation of fraudulent debtor controls via EFTsure. These actions might not seem like things to get too excited about, but they do ensure that the board has protections and measures in place for the protection and appropriate use of club funds.

We have also seen continued efficiencies with shared costs between the SLSC and supporters club. As I've reported previously, we've combined several service contracts and initiatives like photocopiers, phone systems, security and social media services. This year we renewed our photocopier lease agreement with the existing supplier through a competitive negotiation process and now pay per year, what we were paying per month when I first took on the role. This is a great achievement and ensures that we can better utilise those funds to support our members and areas of core focus.

I also want to focus on the positive pieces about our financial position before I deep dive into the key financial figures for the year. All areas of income were up this year apart from merchandise sales and raffles income. These highlight that people are being careful with their disposable income as cost-of-living pressures make an impact. Membership fees are up which complements our statistics of higher membership numbers and work we are doing with Hillcrest. Our overall income was improved on last year by \$452,456 to \$1,861,935.

Not being exempt from the general increases in goods and services and inflation, our expenses also increased by \$206,324 on last year totalling \$819,904. The main contributors to this were increased staff expenses noting that we hired Bella Cera, a substantial increase in uniform costs partly driven by reduced SLSA credits, change of sponsorship logos and increase in product costs as well as many new patrolling members. As a byline to this, we have also subscribed to Upparel so if you have old uniforms or club gear that no longer fits or is damaged, please bring that back to the club so we can dispose of it sustainably. Other stand out costs were around Junior and Youth development activities, member expenses and other expenses which generally sit around the club still wanting to provide the social aspect of being at the club and recognition of deserving members. Insurance also saw a \$7,439 increase, or a 15.4% increase on last year which is pretty typical of the insurance market currently, we are expecting a similar level of increase in the coming year but have looked to mostly absorb that expected cost with only a marginal increase in membership costs for the coming season.

Earlier this year we also settled on our very first bricks and mortar investment property, with a shared contribution of funds coming from the SLSC and Supporters Club. The property is a boutique commercial unit on Ourimbah Road in Tweed Heads and as discussed at our last AGM, fit well within our medium to long term investment strategy, has good proximity to the club to maximise the long-term use benefit for the club and delivers a product that still has relatively high rental demand. This was tenanted in the first few weeks' post settlement on a 1-year lease with a 1-year option and is delivering steady rental returns now that all initial leasing and improvement costs have been taken care of. I would expect that the club would look to this type of investment option again, although given we are getting closer to redevelopment works, any future investment likely lies in the residential space and is funded through debt to avoid materially impacting on our ability to fund future works.

I'll touch on our big fundraisers being Cooly Rocks On and Cooly Gold, both of which require the support of the members of the club to ensure that we are able to run the BBQ's and to provide workforce. I won't go into the exact dollar amount of profit of these events but note that they provide a combined income of \$65k for the year. These events provide a fantastic opportunity for the club to fundraise in short sharp bursts that best utilise your dedication of time and are great social events, with tremendous club spirit and comradery and both events as we all come together for the good of the club. These events also capitalise on the location of our club and the efforts of government, council and private operators to stimulate the southern Gold Coast region, something that we can only continue to look to benefit from as migration and density increases in the area. A big thanks to Mick Taylor and Mark Nowlan specifically, but also to those who assist in organising those events, I also extend those thanks. I also wish to thank Craig Maidment and the supporters club staff for arranging goods donations for Cooly Rocks On with Woolworths and existing food suppliers respectively. This maximises the return to the club immensely.

I also want to highlight the massive effort by our sponsorship committee with a good mix of sponsors and great feedback about what we offer and the sponsors experience. I hope to see this level of activity continue to grow in the coming years as the brand of the club increases in value and businesses see us benefit in investing and being associated with our culture and brand. This also must be extended to a massive and heartfelt thanks to Noel and Sue Holmes and the Alfred and Jean Dickson Foundation for their generous donations to the club and to our youth with no expectation of recognition.

The club maintains a strong cash position, finishing the year with \$462,758 which is an increase of \$151,827 from last year. Noting that the board has invested the majority of this cash into a mix of interestbearing banking products for the short term as we work towards an understanding of project costs for the facilities improvements and the longer-term view of additional development of the club. This interest income can be seen in the earlier parts of the financial statements.

I want to also acknowledge the Queensland Government for their support via the QFES funding as well as some discretionary contributions for repairs and maintenance that have been provided to clubs on a as needs basis in addition to a large contribution to a club facilities upgrade project, Gold Coast City Council and specifically Cr Gail O'Neill for their contribution toward the recent roof repairs as part of the Divisional Funding as well as their continued discounting around rates and services charges. Without these regular and semi-regular contributions to the club, these funds would need to be found from other sources, placing pressure on fundraising and membership fees.

Lastly, I couldn't do what I do without the amazing support from Gabby and Bella from day to day, we work closely with each other and our bookkeepers to ensure that I am able to present accurate and informative reports to the board each month that inform decisions that affect all members of the club. It would also be remis of me (and not make the same mistake twice) to not acknowledge my family for their support and understanding for all the late nights, meetings and distant thoughts of numbers and financial governance.

I look forward to supporting and contributing to the financial growth and success of the club over the next 2 years and congratulate all the members who were successful in obtaining the membership subsidy for the coming year. The board have endorsed this again for the 2025/2026 season as a recognition of members who not only continuously contribute to our core service of saving lives but also selflessly put in massive hours in fundraising, award training and water safety.



Director of Education

This season was all about IRB's with 12 members gaining their IRB Crew certificate and a further 6 becoming IRB Driver's. Other equipment awards gained were 16 SSV Inductions and 13 Tractor Inductions.

Patrolling members continued to grow with 25 new or returning Bronze Medallion awards gained and 36 new SRC's. Our partnership with Hillcrest Christian College last season was also very successful with the club retaining approximately 10 SRC holders who will go on to complete their Bronze Medallion next season.

We hosted 4 Skills Maintenance sessions with the first in September being the most attended. Big thanks to everyone who helps on these days – setting up boats, dropping cans, getting out resus equipment, board and tubes, and of course all the training team.

45 members gained or renewed their First Aid certificate with the assistance of our in-house emergency care trainers Belinda Doman, Joel Kinneally and probationary ECT trainer Damian Ling. We also saw a great uptake by members to upgrade to the new ART certificate with a total of 20 gaining this award.

The updated Silver Medallion Patrol Captains course launched last season with 4 of our members attending and a further 8 completed the course this season. The course puts candidates in stressful situations where they move through scenarios on or around the beach. Being put on the spot in front of peers can be quite intimidating and outside of people's comfort zones so a big thankyou and congratulations to those who gained this award.

SLSQ brought out huge changes this year with the introduction of the SLSQ Hub and aXcelerate assessment portal. A promise to make life easier for trainers could not have been further from the truth with Belinda, Joel, Gab and myself spending countless hours troubleshooting problems so members could have their awards processed. It almost broke us but THANKYOU for persevering!!

Bronzies Day was extra special with attendees hearing from 3 brave and selfless members of our club – Brad Marsden, Terry Simpson and Brendon Smith. Brad shared his heroic stories of risking his own life to save others. Terry stepped in when others wouldn't and successfully resuscitated a local man. And Brendon spoke of the reality of time in the military and the wonderful culture at Coolangatta SLSC.

A quote from Terry that really resonated with me is "Small decisions have a huge impact on so many people". It's easy to go through the motions on patrol or at skills maintenance but I urge members to take those opportunities to ask questions and to practice until they feel comfortable. We have learnt the skills to save someone's life, but do you feel confident you could?

The training team are always happy to make time for those who want to learn, and I am truly grateful to be surrounded by such knowledgeable and dedicated people. Belinda Doman, Joel Kinneally, Damian Ling,

Dion Ezzy, Peter Selosse, Phil Hammond, Alistair McCooke and Gabrielle Kinneally, without you the club could simply not exist.

Grants Officer

We have had a very successful year in Grants this season, which has seen us obtain a significant amount of funds, gear and equipment that are vital for the day-to-day operation of our SLSC.

Through various grant opportunities, we have gained funding for tents, tablets and new IRB's.

Most notably, we were successful in the QLD Governments Minor Infrastructure and Inclusive Facilities Fund (MIIFF). Through this Grant, we have successfully obtained \$350,000.00 in funding towards a much-needed update and modernisation of our toilet/shower/changeroom facilities. This is a huge financial boost for our club, particularly as we look to undertake further extensive renovation work to the rest of the club in the not-too-distant future.

Also, Susan and the SLS Grant Seeking Unit for their assistance and guidance throughout the process. Together we have achieved an outstanding outcome for our club.

Moving forward, we will continue to pursue a range of Grant opportunities that will stand to benefit all members of our club.

It has been a busy season and whilst progress has been slow on the building redevelopment and proposed extensions, I can report it has been very positive.



Earlier in the season we were successful in obtaining some funding through the City of Gold Coast that enabled us to undertake a roof restoration that addressed the issues we were

having with leaks. These works seem to have done the job and we have had no further issues with leaks as a result.

On the 11th of April key stakeholders from the Club and the City of Gold Coast met regarding our proposed extension to the building. In our discussion Council indicated they were supportive of our proposal to extend the building and asked if we would be interested in doing it as a 2-part project. The proposal was that the SLSC storage area would be part 1 and the proposed outside dining above in the supporter's club would be part 2. Based on advice we had received; we declined this offer advising that the design had to be built as one single project.

Council was keen for us to demonstrate how we would fund such a project and we were able to showcase the strong financial position that the club is in which was looked upon favourably by the council. We have estimated the extension and renovation for our club would cost approximately \$6 million.

During the meeting Council also turned discussion to Board Short Barista (BSB) and how the grass area out the front was very worn. Despite the clubs' best efforts to maintain this area, it is a high traffic area and keeping the area looking nice is proving a challenge.



As part of the re-development proposal Council would like us to engage a landscape architect to come up with a long-term solution to maintain this area. This project would be conducted in conjunction with the overall re-development plan and will be in the best interest of the club and the local community. At this stage Council are expecting the club to cover the cost of this project, however it is felt that we should negotiate for it to be a 50/50 contribution project. We are currently in early discussions with a landscape architect to come up with a suitable design and some costings as the plans (below) from council are very high end and not durable. I feel that this request should be done in good faith with the council as I believe it's going to help with our proposed building extension into the park.

During discussion with the council around the proposed changes to the SLSC, council have indicated their concerns around the current bunkrooms and whilst they are fireproof rooms there is no fire exit. There are other concerns that are also being considered. We are currently conducting a feasibility study around the use of the bunkrooms to determine the best course of action. All other changes we have proposed have been accepted for now.

Later in the season we were successful in obtaining a grant for \$350k to renovate the bathrooms. A plan has been drawn up for the proposed changes and these are work in progress now as the grant monies need to be spent and acquitted by November 2025.

In recent weeks we also met with SLSQ regarding some possible facilities funding to assist with the club extension. This was a very positive meeting in so many ways and I'm hoping to be able to tell you all how successful we have been at our AGM.

I would like to pass on my thanks to the members who have taken the time to provide feedback and suggestions about the club refurb through the survey link. These suggestions have been reviewed and all will be considered during upcoming discussions.

At this stage we are hoping to start to move forward with our proposed extension in 2026 which would be fantastic.

Finally, I would like to thank the Building Committee for their support and guidance with this exciting project.

This season, Coolangatta SLSC was privileged be asked to host an inclusive Nippers program in partnership with Autism Swim, thanks to the sponsorship provided by SLSQ. This initiative marked us as the pilot club for such a program in Queensland.

While programs like this aren't new, and Coolangatta has run the Bluebottles special needs Nippers' programs in the past, this particular initiative stands out for several reasons. Firstly, it was aimed at a specific target group, ensuring a focused and tailored approach. Secondly, the program, known as Dippers, is inclusive and runs concurrently and at the same location as our regular Nipper program. This promotes integration and mutual understanding.

A key differentiator for this program is our partnership with Autism Swim, who provided us with an exceptional local clinician, Alicia Bains. Alicia's role was pivotal in coordinating the program, ensuring its smooth operation and having the skills and expertise to understand the unique needs of the participants. Another significant aspect of this program was the training undertaken by our volunteers. This training equipped them with the necessary skills and understanding to effectively support the participants, enhancing the overall impact and effectiveness of the program.

These unique elements combined to create a program that was not only beneficial for the participants but also enriched our club community as a whole. It's a testament to the power of inclusivity, targeted support, and ongoing education.

Autism Swim took the lead in advertising the program and managing registrations, while our club focused on engaging suitable volunteers to pair with the children. We successfully hosted eight children in the Dippers program, each paired with a primary helper and a water safety officer. The program ran every Sunday morning for eight weeks alongside our nipper program starting from 21st January and concluding on 10th March to coincide with the Nippers' season end.

The children all became members of the club and were issued with their pink rash vest which they wore with pride, just like all the other nippers. Ranging in age from 5 - 16 years and came to us with varying abilities, the kids had a fantastic experience. Every enjoyed the program and had a huge smile on their face and a sense of accomplishment at the end of the 8-week program. Each of them increased their confidence in the ocean and the parents were so appreciative of the opportunity for their child to participate.

Note 1 Summary Of Significant Accounting Policies

(a) Basis of Preparation

The Committee has prepared these financial statements on the basis that the Association is a nonreporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in accordance with the Australian Accounting Standards and the Australian Charities and Not-for-profits Commission Act 2012.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

Coolangatta Surf Life Saving Club Incorporated is a not-for-profit entity for the purpose of preparing these financial statements. The financial statements have been prepared on an accruals basis and are based on historical costs modified by the revaluation of selected assets and financial instruments for which the fair value basis of accounting has been applied.

(b) New Accounting Standards Applicable During the Year

There were no new standards applicable during the year that have a material effect on these financial statements.

(c) Overall Considerations

The significant accounting policies that have been used in the preparation of these financial statements are summarised below. All policies were applicable in the prior year unless otherwise stated.

(d) Revenue

Operating Grants, Donations and Bequests

When the club receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the club: - identifies each performance obligation relating to the grant - recognises a contract liability for its obligations under the agreement - recognises revenue as it satisfies its performance obligations. Where the contract is not enforceable or does not have sufficiently specific performance obligations, the club:

- a) recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (for example, AASB 9. AASB 16, AASB 116 and AASB 138)
- b) recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)
- c) recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the club recognises income in profit or loss when or as it satisfies its obligations under the contract.

(d) Revenue (Continued)

Interest Income

Interest income is recognised using the effective interest method.

Revenue from the sale of goods

Revenue from sale of goods comprises revenue earned from sale of goods donated and resale. Sales revenue is recognised when the control of goods passes to the customer.

Rental Income

Rental income is accounted for on a straight line basis over the lease term.

All revenue is stated net of the amount of goods and services tax where applicable.

d) Impairment of Assets

Assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use.

e) Inventories

Inventories are measured at the lower of cost or net realisable value.

f) Right of Use Assets and Lease Liability

The Association recognises a right-of-use asset and a lease liability at the lease commencement date, which is the date that the lessor makes the asset available for use by the Association.

The right-of-use asset is initially measured at cost, which comprises:

• the amount of the initial measurement of the lease liability;

• any lease payments made at or before the commencement date, less any lease incentive received; and

• any initial direct costs incurred by the Association.

After the commencement date, the right-of-use asset is measured at cost less any accumulated depreciation and any accumulated impairment losses. Right-of-use assets are depreciated using the straight-line depreciation method, from the commencement date to (a) the end of the useful life of the underlying asset, in case the lease transfers ownership of the underlying asset to the Group by the end of the lease term, or the lease contains a purchase option that the Group is reasonably certain to exercise, or (b) the earlier of the end of the useful life and the end of the lease term, in all other cases.

g) Right of Use Assets and Lease Liability (Continued)

Lease liability

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the respective Association's incremental borrowing rate. Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments, less any lease incentives receivable;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option; and
- payments of penalties for early terminating the lease, if the Group is reasonably certain to exercise an option to early terminate the lease.

After the commencement date, the lease liability is measured by:

- increasing the carrying amount to reflect interest on the lease liability;
- reducing the carrying amount to reflect the lease payments made; and
- remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect the impact from a revised index or rate.

h) Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

i) Cash and Cash Equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. Bank overdrafts are shown within short term borrowings in current liabilities on the balance sheet.

j) Trade and Other Receivables

Trade receivable amounts due from customers and other receivables represent the principal amounts due at balance date less, where applicable, any unearned income and provisions for doubtful accounts. A provision for impairment of trade and other receivables is made when there is objective evidence that the Association will not be able to collect the debts. Bad debts are written off when identified.

k) Trade and Other Payables

Trade and other payables represent the principal amounts outstanding at balance date plus, where applicable, any accrued interest.

I) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the Australian Tax Office. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the balance sheet.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the Australian Taxation Office, are presented as operating cash flow.

m) Income Tax

The Association is exempt from income tax under the provisions of Section 50-10 of the Income Tax Assessment Act 1997.

n) Critical Accounting Estimates and Judgements

The Committee evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Association.

o) Property Plant and Equipment

The depreciable amount of all fixed assets are depreciated on a straight-line basis or diminishing value over the asset's useful life commencing from the time the asset is held ready for use. Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment over their expected useful lives as follows:

•	Buildings	25 years
•	Motor Vehicles	4 years

Plant and equipment 3 years

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Association. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Plant and equipment are measured on the cost basis less depreciation and any impairment losses.

p) Investment Properties

Investment properties are initially recorded at cost, and subsequently measured at cost less depreciation and impairment charges. The Association has one investment property which it has estimated the useful life is 40 years.
